CTPF Members,

Information and guidance from federal, state and city agencies on the COVID-19 outbreak has been evolving rapidly. The health and well-being of our members and staff, as well as the continuation of business operations, are our primary concerns.

On Friday afternoon, the Governor announced plans to close all schools in Illinois, starting Tuesday, March 17, 2020. Yesterday, he closed all of Chicago's bars and restaurants for dine-in service through March 30. The Governor has urged companies to have employees work from home when possible in order to help #flattenthecurve.

CTPF pensions are secure and are not based on market conditions. We have procedures in place to ensure the payment of member benefits, even when normal business may be interrupted.
