Your Member ID

You will see your Member ID number on all CTPF correspondence and documents. Active members will see Member IDs on their Statement of Estimated Contributions and Benefits (*sent in the fall*), and retirees will see Member IDs on their pay advices. You still have the option of using the last four digits of your social security number when communicating with CTPF in writing, or your full social security number when contacting our office via phone (*when calling Member Services*), but it has been eliminated from all outbound documents and correspondence.
