2023 Open Enrollment

The 2023 Open Enrollment Period will run from October 1-31, 2022. During this time, annuitants can enroll, add or drop a dependent, or change a health insurance plan or carrier. Changes become effective January 1, 2023.

The Board of Trustees voted to continue the 60% premium subsidy for 2023.

The 2023 Open Enrollment Handbook is now available online. Handbooks were mailed in mid-September by first-class mail, for delivery by October 1.

State certified teachers or administrators employed by a private school recognized by the Illinois State Board of Education, who have served as a contributing teacher for a CTPF employer for at least 10 years, may be eligible to purchase that private teaching service and have that credit added to total years of service. 2022 Return to Work Updates

A CTPF retiree may decide to return to work as a teacher, but there are some rules to be aware of to avoid a pension suspension, cancellation, or possible benefit overpayment. Returning to work on a permanent, annual basis will generally result in your pension being immediately cancelled, to resume only upon re-retirement. In 2022, the Illinois General Assembly passed two measures designed to help



address the shortage of substitute teachers/administrators. The Fund also updated its Administrative Rules to align with the new legislation. Find more information here, ctpf.org/returntowork.

Each pay period, Employers remit employee pension contributions to CTPF. Illinois law requires that these contributions be made within a certain time period.
