2023 Open Enrollment

The 2023 Open Enrollment Period will run from October 1-31, 2022. During this time, annuitants can enroll, add or drop a dependent, or change a health insurance plan or carrier. Changes become effective January 1, 2023.

The Board of Trustees voted to continue the 60% premium subsidy for 2023.

Final Reminder: Health Insurance Rebate

Annuitants who have health insurance coverage from another source between January 1-December 31, 2021, received a mailing detailing the process for applying for a premium subsidy. Applicants must complete and return the application (Form 355). The deadline to submit applications was August 31, 2022, with a grace period extended to **September 16**,

2022. Applications postmarked after September 16, 2022, will not qualify for a 2021 rebate.
