Public School Teachers' and Employes' Retirement Fund

In May, 1895, the Legislature of Illinois passed the following pension law which went into effect on July 1, 1895:

Pension Law.

AN ACT TO PROVIDE FOR THE FORMATION AND DISBURSEMENT OF A PUBLIC SCHOOL TEACHERS' AND PUBLIC SCHOOL EMPLOYES' PENSION AND RETIREMENT FUND IN CITIES HAVING A POPULATION EXCEEDING ONE HUNDRED THOUSAND INHABITANTS. A PPROVED MAY 31, 1895. IN FORCE, JULY 1, 1895.

Sec. 312a. Board of education in cities having population of over 100,000—power to create such fund: 1. Be it enacted represented in the General Assembly. That the board of education in cities having a population exceeding one hundred thousand inhabitants, shall have power, and it shall be the duty of said board to create a public school teachers' and public school employes' pension and retirement fund, and for that purpose set apart the following moneys, to-wit:

1. An amount not exceeding one per cent per annum of the respective salaries paid to teachers and school employes elected by such board of education, which amount shall be deducted in equal installments from said salaries at the regular times for the payment of such salaries.

2. All moneys received from donations, legacies, gifts, bequests, or otherwise, on account of said fund.

3. All moneys which may be derived from any and all sources: Provided, however, That no taxes shall ever be levied or an appropriation of public money be made for said fund except as herein provided.

Section 312b. Board of trustees—how created—powers of—2. The board of education, together with the superintendent of schools, and two representatives to be elected annually by the teachers and employes of the public schools under control of said board shall form a board of trustees, a majority of whom shall determine the amount to be deducted from the salaries paid to teachers and employes as aforesaid, and shall have charge of, and administer said fund, and shall have power to invest the same as shall be deemed most beneficial to said fund, in the same manner and subject to the same terms and conditions as township treasurers are permitted to invest school funds in Article Four (4) of

an act entitled "An act to establish and maintain a system of free schools," in force May 4, 1889, and shall have power to make payments from said fund of annuities granted in pursuance of this and shall from time to time make and establish such rules and regulations for the administration of said fund as they shall deem best.

Sec. 312c. Rules for retirement of teachers—3. Said board of education shall have power by a majority vote of all its members to retire any female teacher or other female school employe who shall have taught in public schools or rendered service therein for a period aggregating twenty years; and any male teacher or male school employe who shall have taught or rendered service for a period aggregating twenty-five years, and such teacher or school employe also shall have the right after said term of service to retire and become a beneficiary under this act; Provided, however, That three-fifths of said term of service shall have been rendered by said beneficiary within the limits of the municipality where said board of education has jurisdiction.

Sec. 312d. What annuity retired teachers may receive—4. Each teacher and school employe so retired or retiring shall thereafter be entitled to receive as an annuity one-half of the annual salary paid to said teacher or employe at the date of such retirement, said annuity to be paid monthly during the school year: Provided, however, That such annuity shall not exceed the sum of Six Hundred Dollars (\$600.00), which sail be paid by said board of education out of the fund created in accordance with this act in the manner provided by law for the payment of salaries

Sec. 312e. How principal and interest of fund for payment of annuities to be used—5. Said board of trustees is hereby given the power to use both the prantipal and income of said fund for the payment of annuities hereinbefore rentioned, and shall have power to reduce, from time to time, the amount of all annuities. Provided, That such reduction shall be at the same rate in all cases.

sec. 312f. Monthly certificates amounts deducted from salaries made to the city treasurer—special find—how and when drawn—6, and production shall certify monthly to the city treasurer all amounts deducted from the salaries of teachers, special teachers principals and employer of the board of

education in accordance with the proeducation in accordance with the provisions of this act, which amounts as well as all other moneys contributed to said fund, shall be set apart and held by said treasurer as a special fund for the purposes hereinbefore specified, subject to the order of said board of education, superintendent of schools, and two representatives as aforesaid and shall be paid sentatives, as aforesaid, and shall be paid out upon warrants signed by the presi-dent and secretary of said board of edu-

Sec. 312g. Treasurer—custody of pension fund, books and accounts—inspection—bond—7. The city treasurer shall be custodian of said pension fund, and shall secure and safely keep the same subject to the control and direction of said board of trustees, and shall keep his books and accounts concerning said fund in such manner as may be prescribed by the said board. And said books and accounts shall always be subject to the inspection of the said board or any member thereof.

The treasurer shall, within ten days

of the said board or any member thereof.

The treasurer shall, within ten days af ar his election or appointment, execute a bond to the city with good and sufficient securities in such penal sum as the said board shall direct, to be approved by the said board, conditioned for the faithful performance of the duties of his office, and that he will safely keep and well and truly account for all moneys and profits which may come into his hands as such treasurer and that on the expiration of his term of office he will surfrender and deliver over to his successor all unexpended moneys and all property which may have come into his hands as terasurer of such fund. Such bond shall be filed in the office of the clerk of such city, and in case of breach of the same or the conditions thereof, suit may be brought on the same in the name of said city for the use of said board of trustees or of any person or persons injured by such beautiful the same of the same in the same is the same of the same of breach. breach.

Sec. 312h. Removal of teacher, etc.—

at any time a teacher or school If at any time a teacher or school employe who is willing to continue is not re-employed or is discharged before time when he or she would under provisions of this act be entitled to pension, then such teacher or school entitled to shall be paid back at once all the money with interest he or she may have contributed under the law.

RESOLVED, That the board of education grant the petition and designate the 27th day of November, 1895, as the day 27th day of November, 1895, as the day for the meeting and organization of the board of trustees provided by the Pension Law, approved May 31, 1895, in force July 1, 1895; that the place of the meeting shall be at the assembly room of the board of education, aforesaid, and that the same shall convene at 8 o'clock n. m. on the said date and that the teach p. m. on the said date and that the teachers and school employes are requested to select the two representatives required by the said law at as early a date as may be convenient, and in order to facilitate action in that direction, it is suggested, at the request of the committee of teachers, that each school within the city of Chicago select one representative from among teachers and school em-ployes to attend a meeting to be held in ployes to attend a meeting to be held in the Schiller theatre on the morning of the 16th inst. at 10 o'clock a. m., for the purpose of devising a plan for selecting the two representatives aforesaid; that nominations be made at said time if deemed wise by those assembled and that the names of candidates be printed and submitted to each and every teacher and school employe; that a ballot be provided and that each teacher and school employe vote for two said representatives and return said ballot to a committee to be selected by the assembly to convene as aforesaid upon the sembly to convene as aforesaid upon the sembly to convene as aforesaid upon the 16th inst.; that said ballots be returned and that the successful persons be declared elected upon the 23rd of November, and that they take their seats with the members of the board of education and superintendent of schools upon the 27th day of November to organize said board of trustees under said pension law.

Mr. Thornton's motion to adopt was seconded by Mr. Errant and it was so ordered.

In accordance with this action a meet-In accordance with this action a meeting was held on Saturday, November 16th, 1895, in the Schiller Theatre. At this meeting, which was composed of representatives from the teachers and from the employes nominations were made for trustees of the Pension Fund and a committee appointed to canvass the votes, which were to be returned and canvassed on November 23rd, 1895.

RESOLVED, That in preparing the pay rolls of the office and business employes of the Architect's Department, the Compulsory Education Department and the Engineers and Janitors of the Chicago Public Day Schools, there be deducted from the month of January, 1896, one per cent from the salaries to be paid to the various employes mentioned on said pay rolls; such deduction being in conformity with the Public School Teachers' and Employes' Retirement Act of 1895 and in accordance with the recommendation of the board of trustees of the Teachers' Pension and Retirement Fund and that said amount be deducted from the above mentioned pay rolls for each month following until otherwise ordered by this board; the amounts so deducted to be deposited with the provisions of said Teachers' and Employes' Pension and Retirement Fund Employes' Pension and Retirement Fund Employes' Pension and Retirement Fund Law. Section I.—The official title of this Board shall be The Board of Trustees of the Public School Teachers and Employes' Retirement Fund of the City of Chicago.

Sec. II.—Stated Meeting—The stated meetings of the Board shall be held immediately after the adjournment of the the Board of Education at its first regular meeting in the months of January, April, July, and October.

Sec. III.—Special Meetings—Special meetings may be called at any time by the President, or on the written request of five members.

meetings may be called at any time by the President, or on the written request of five members.

Sec. IV.—Officers—The officers shall be a President, a Vice-President, and a Secretary, who shall be elected for one year, and a Treasurer who is designated by law. The annual organization shall be made at the regular meeting in July, or as soon thereafter as practicable.

Sec. V.—Duties of President—The President shall preside at all meetings; shall be Ex-Officio a member of all standing committees; shall sign orders for money that have been passed upon by the Board of Trustees; shall appoint all committees.

Sec. VI.—Duties of Vice-President—In case of the absence of the President, or of a vacancy in the office of President, all the powers and duties of that office shall devolve temporarily, on the Vice-President.

office shall devolve temporarily, on the Vice-President.

Sec. VII.—Duties of Secretary—The Secretary shall keep a record of the transactions of the Board and shall have charge of all documents belonging to the Board, shall, with the President, sign orders for money passed upon by the Board of Trustees, and shall perform such other duties as pertain to the office such other duties as pertain to the office

such other duties as pertain to the office of Secretary.
Sec. VIII.—Duties of the Treasurer—
The City Treasurer shall be custodian of said pension fund, and shall secure and safely keep the same subject to the control and direction of said Board of Trustees, and shall keep his books and accounts concerning said fund in such manner as may be prescribed by the said Board. And said books and accounts shall always be subject to the inspection of the said Board or any member thereof.

The Treasurer shall, within ten days after his election or appointment, execute a bond to the City, with good and sufficient securities, in such penal sum as the said Board shall direct, to be approved by the said Board, conditioned for the faithful performance of the duties of his office, and that he will safely keep, and well and truly account for all moneys and profits which may come into his hands as such Treasurer, and that on the expiration of his term

of office he will surrender and deliver over to his successor all unexpended moneys and all property which may come into his hands as Treasurer of such fund. Such bond shall be filed in the office of the Clerk of such city, and in case of a breach of the same or the conditions thereof, suit may be brought on the same in the name of said city for the use of said Board of Trustees or of any persons injured by such breach. such breach

Sec. IX.—Committees—There shall be

X.—Duties of the Committee on Finance—The Committee on Finance shall audit and certify all bills; shall quarterly count and examine all securities in the hands of the Treasurer; shall report at the regular meetings the condition of the Retirement Fund, and shall make investments under the direction of the Board of Trustees.

Sec. XI.—Duties of the Committee on Annuities—All applications for annuities shall be referred to this Committee. Said Committee shall consider such application and make its recommendations at the first regular meeting of the Board after the presentation of said applications, provided three months shall have intervened.

Sec. XII.—Duties of the Committee on Claims—All applications from the heirs of decedents, and from dismissed teachers and employes shall be referred to the Committee on Claims, which shall consider and make recommendations on the same to the Board.

Sec. XIII.—Duties of the Committee on Judiciary—The Committee on Judiciary shall have the supervision of the legal affairs of the Board. All questions involving the amendment, construction, revision, or supervision of the Rules and Regulations shall be referred to that Committee.

Sec. XIV.—Quorum—A majority of the Board shall constitute a quorum for the transaction of business. A majority of any committee shall constitute its quorum.

Sec. XV.—Expenditure—All reports and resolutions, involving an expenditure of money, shall require a majority vote of the Board.

XVIII.—Refunding of Money—Any teacher, or employe, desiring the restoration of money paid into the Retirement Fund, because said teacher, or employe, has been discharged, or not re-employed, before the time when he or she would be entitled to an annuity, shall make written application on the official blank, adopted by the Board.

Sec. XIX.—Teachers and employes retiring before contributing to the Fund, 3-5 of 20 years, or 3-5 of 25 years. Until January, 1908, the Secretary of the Board of Trustees shall withhold from the annuity of each and every woman annuitant, a sum equal to one per cent of the salary received by said annuitant at the time of retirement; a similar percentage shall be withheld yearly, from each and every man annuitant until January, 1911.

Sec. XX.—Refusal of An Annuity—This Board reserves to itself the right to refuse an annuity to a teacher, or employe, who has served the requisite number of years, and is discharged, or not re-elected by the Board of Education.

Sec. XXI.—Election of Representative

Sec. XXI.—Election of Representative Trustees—The annual election of two trustees by the teachers and employes shall take place the first Tuesday in November. On the first Saturday in October, there shall be held in each of the seven School Districts, at the hour and in the places designated by the Board of Trustees, a meeting consisting of one delegate from each primary, grammar, and high school within the given district. These delegates shall nominate two trustees and forward to the Secretary of this Board the names of the nominees. The Secretary shall print Australian ballots containing the names of the nominees from the seven districts. Voters shall be registered by the principals of the various schools two weeks before the election. Ballots cast shall be forwarded to the Secretary, who with one delegate from each of the seven nominating conventions shall count them and report the results to this Board. this Board.

Pursuant to the resolution of your Honorable Body of July 26th ult., that I, as Attorney of the Board, "be instructed to prepare an opinion as to whether, under the new system of certification of new employes of the Board by the Civil Service Commission, the Engineers, Janitors and other employes would come under the Pension Law." I beg leave to herewith submit my opinion thereon. thereon.

Section 1 of the Teachers' Pension and Retirement Fund Act, makes it the duty of the Board of Education to create a Public School Teachers' and Public School Employes' Pension and Retirement Fund, and to set apart one per cent per annum of the respective salaries paid to teachers and school employes elected by said Board of Education.

by said Board of Education.

Sec. 2 of said Act provides that the Board of Education, together with the Superintendent of Schools and two representatives to be selected annually by the teachers and employes of the public schools under the control of said Board, shall form a Board of Trustees who shall have charge of and administer said fund. Sec. 8 of said Act provides that "not teacher or other school employe who has been, or shall have been, elected by said Board of Education shall be removed or discharged, except for cause, upon written charges which shall be investigated and determined by the said Board of Education, whose action and decision in the matter shall be final. If, at any time, a teacher or school employe who

is willing to continue, is not re-employed or is discharged before the time when he or she would, under the provisions of this Act, be entitled to a pension, then such teacher or school employe shall be paid back at once all the money, with interest, he or she may have contributed under the law."

Under the new system of certification by the Civil Service Commission of new employes who have, or may hereafter secure employment by the Board of Education, there seems to be no change of the status of said employes, so far as the Board of Education is concerned, from what it was prior to such certification. The only possible change that I am able to discover in the new procedure is, as to the method of election of said employes. Prior to the certification designates eligible candidates for the various positions to be filled, and the Board, by accepting the service Commission designates eligible candidates for the various positions to be filled, and the Board, by accepting the services of such employes, in effect elects them to their several positions, so that in point of fact, the relation of the Board to its employes, as regards both their hiring and discharge, is in no wise changed.

These acts were passed at the same session, the Civil Service act having been approved, with an emergency clause, March 20, 1895, and the Teachers' and Employees' Pension act June 21, 1895; but the Civil Service act did not become operative until after it was adopted by the electors of the City of Chicago and declared to be in force by the proclamation was issued July 1, 1895. It is the duty of the courts to construe the two acts so as to give effect to both, as far as may be done. But it is apparent that the two acts are inconsistent, so far as the power of removal of employees of the board is concerned. There is, however, no other repugnancy between them. Giving effect to the provision of the Pension Act as the latest expression of the legislative will, we are of the opinion that the circuit court was right in holding that the board of education has the power to investigate and determine charges against its employes and to remove or discharge them, but that in all other respects the Civil Service act applies to such employees according to its terms. This exception is necessarily created by the later act and may well have been made because of the purpose of the act to create, and preserve under the control principally of the board of education, for teachers and employes, a pension and retirement fund. But, whatever the purpose may have been, the act must have its intended effect."

I am, therefore, of the opinion that in principle, as well as by authority of the foregoing decision of the Supreme Court, that all employes of the Board of Education are as fully within the provisions of the Pension Law as they were prior to the adoption of the present system of certification.
