



2022 Open Enrollment

Open Enrollment Period for health insurance will run from October 1 - 31, 2021.

The 2022 Open Enrollment Period will run from October 1-31, 2021. During this time, annuitants can enroll, add or drop a dependent, or change a health insurance plan or carrier. Changes become effective January 1, 2022.

CTPF will offer expanded educational programs by webinar and phone conference this fall. Telephone and video counseling appointments with counselors from CTPF's Member Services department are also available.

Health Insurance Premium Subsidy

The Health Insurance Premium subsidy is set annually. At the August 19, 2021, Board of Trustees meeting, the Trustees voted to continue to subsidize 2022 health insurance premiums at 60% (certain limitations may apply).

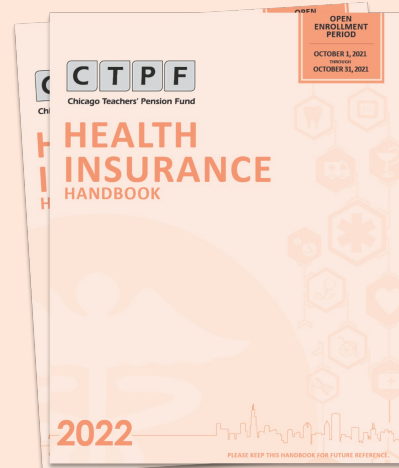
