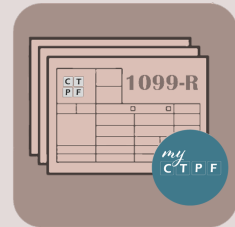


Holiday Office Closings

1099-R Printing Error Identified

Revised 1099-R Forms Now Available in the myCTPF Member Self-Service Portal



The 2023 1099-R forms issued by CTPF on January 31, 2024, included an error and are being reissued. The boxes in Section 2B were checked incorrectly. No other sections were impacted by the error. The form mailed on January 31, 2024, should not be used to file your tax returns.

The revised 1099-R is now available in the [myCTPF Member Self-Service Portal](#). The vendor will reprint the 1099-R and new forms will be mailed as soon as possible. Please note that correct information has been reported to the IRS, and the new document you receive will not be considered a "1099-R Corrected" document for tax purposes.

If you have already filed your tax return, please check with your tax preparer to determine what action you may need to take. CTPF cannot offer tax advice.

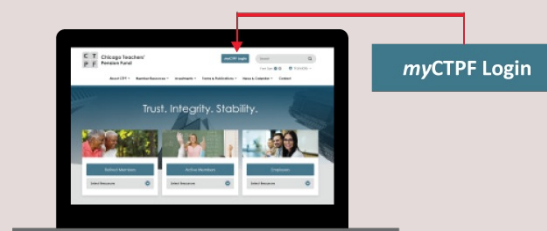

- View your benefit status information.
- View and download 1099-R and pay advice(s) (pensioners)
- View and download your annual Member Statement if you have service credit with CTPF.
- Request an estimate of your CTPF retirement benefit (if you meet the eligibility



requirements).
