The purchase of military service for public employees is a benefit designed to partially compensate veterans for their service in the armed forces. Any **active duty** military service credit purchased, is applied toward the calculation of your CTPF benefits. Eligibility for a pension or retirement pay from the U.S. government does not affect your eligibility to purchase military service with CTPF. **Please read the requirements, the instructions and the application form carefully and complete all information as requested.** Incomplete forms will necessitate additional communication and delay the processing of the request.

	To apply to purchase military teaching service credit you must be a regularly certified, full-time appointed teacher contributing to CTPF . Your application to purchase military service credit must be received by CTPF and payment completed before you receive your first retirement check from CTPF or another retirement system covered by the Illinois Retirement Systems Reciprocal Act (if retiring under reciprocity). You may purchase a maximum of 5 years active duty , two of which may precede your teaching career with a CTPF-covered employer		Cost to purchase service prior to participation: Member contributions and employer cost of the benefit plus 5% interest compounded annually from the date of your appointment in CT to the date of repayment. Salary used to calculate cost is sal from first date of appointment as a regularly certified teach. This service credit will not be added to your account until y have paid the entire bill.
