Thank you for serving as your school's Pension Representative. Pension Reps provide a valuable link between schools and CTPF and we appreciate your assistance throughout the year.

This fall, CTPF will hold elections for Two Teacher Trustees who will serve three-year terms from November 2024-November 2027 and one Principal/Administrator Trustee who will serve a one-year term from November 2024-November 2025. All eligible voters will receive a unique voter identification number by mail and, if



available, by email. Online voting will open the day materials are mailed, the week of October 14, 2024. Voting closes on November 1, 2024, at 5:00 p.m. (CT).

# **Candidate Nomination Packets**

Candidate nomination packets are available. Contact Election Coordinator Gail Davis, at <a href="mailto:elections@ctpf.org">elections@ctpf.org</a> to request a packet. Please note, the nominating petitions cannot be altered or changed in any way. Do not add photos or additional information to nominating petitions. Signatures may be collected with paper petitions, using the online digital collection system developed by the Election Agent, or a combination of both methods.

A **Teacher Trustee** candidate's signed nomination petition(s), resume, and photo, must be received by the Election Coordinator or his/her designee, on behalf of the Recording Secretary, by U.S. Mail, email, or facsimile on or after September 16, 2024, but no later than October 1, 2024, at 5:00 p.m. (CT).

A **Principal/Administrator Trustee** candidate's signed nomination petition(s), resume, and photo, must be received by the Election Coordinator or his/her designee, on behalf of the Recording Secretary, by U.S. Mail, email, or facsimile no later than October 1, 2024, at 5:00 p.m. (CT).

The Fund reserves the right to request a candidate's original nomination petitions. Nominating petitions, resumes, and photos received after the deadline will not be accepted.

Election packets were mailed to schools in April. The packet includes an election notice, the 2024 Credentials Form, and other helpful information. CTPF is asking all Pension Reps to assist in sharing election information via digital distribution and posting in schools.
