*Open Enrollment for health insurance
will run from October 1 - 31, 2023*

The 2024 Open Enrollment Period will run from October 1-31, 2023. During this time, annuitants can enroll, add or drop a dependent, or change a health insurance plan or carrier. Changes become effective January 1, 2024.

CTPF will offer expanded educational programs by webinar and phone conference this fall. In-person, telephone, and video counseling appointments with counselors from CTPF's Member Services department will also be available.

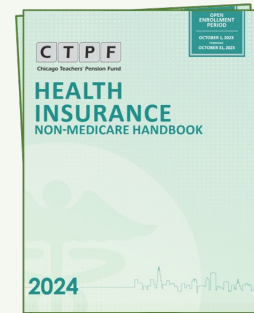
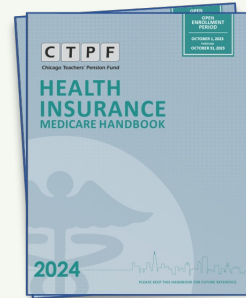
All plans offered in 2023 will be offered in 2024. You do not need to take any action to stay enrolled.
