Voting Closes Today in 2023 CTPF Board of Trustees Elections

Voting in the CTPF Teacher and Pensioner elections opened October 16, 2023, and closes at **5:00 p.m. (CT) today, November 3, 2023**. Teachers vote online and Pensioners vote online or with a paper ballot. Voting credentials were mailed to members' home addresses and the Fund's election agent sent emails with voting credentials to members with email addresses on file.

The person selected must be a certified teacher.
