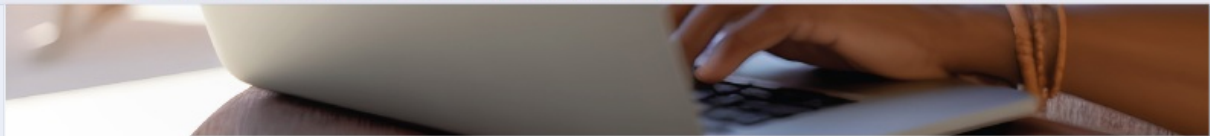

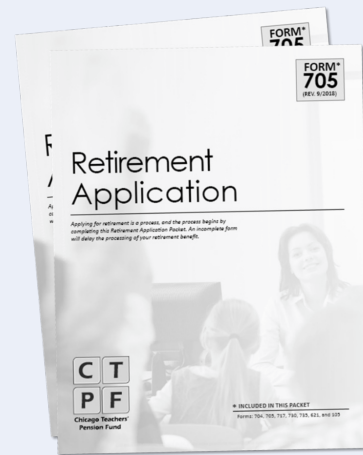

PREPARING FOR RETIREMENT

Here are a few steps to take now if you plan to retire in 2024:

- Register early for a CTPF Retirement Webinar. If you register by February 9th for the February 19th webinars, or by March 15th for the March 26th webinars, CTPF will provide you with a pension estimate, if applicable.
- Download and refer to the retirement checklist in the Application for Service Retirement for a list of all required documents. The application can be accessed online at ctpf.org/retirement-resources.
- Collect or obtain the required personal identification documents listed on the checklist. Missing documentation will cause processing delays.
- Member Services offers phone, video, and in-person counseling appointments. Call Member Services at 312.641.4464 or email memberservices@ctpf.org to request an appointment. Note: Walk-in appointments are not accepted. Visitors need to be added to the building's security list in advance of their visit.
- Check your most recent Member Statement by logging on to your myCTPF Member Self-Service Portal and confirm that your personal information is up to date. Address and demographic changes need to be made with your employer if you are still employed. Find more information at ctpf.org/annual-member-statement.



PENSION ESTIMATE

Members who register in advance (*see deadlines above*) will receive a pension estimate via mail to the address on file. Please make sure your address on file is up-to-date by logging on to *myCTPF* or by calling Member Services at 312.641.4464.



SUBMIT FORMS ELECTRONICALLY

For efficient processing, CTPF encourages members to send benefit applications, forms, and documents by fax 312.641.7185 or email an attachment (.pdf or .jpg format) to imaging@ctpf.org. After documents are sent via fax or email, please mail the originals to CTPF.



REGISTER FOR *myCTPF*

CTPF encourages all members to join its member self-service portal, *myCTPF*. Members who register for *myCTPF* create their own unique User ID and password. Once an account is created, members can use *myCTPF* to securely access CTPF documents and information. Register today at ctpf.org.
