## 2023 Health Insurance Rebate Reminder

Members who received and paid for health insurance coverage from another source between January 1-December 31, 2023, received a mailing in early March of 2024 detailing the process of applying for a health insurance premium subsidy.

Applicants must complete and return Form 355 and return it to CTPF with all required documentation no later than July 31, 2024 (**NEW DEADLINE with NO exceptions**).

The [myCTPF](https://myctpf.org) Member Self-Service Portal includes helpful features for active and retired members:

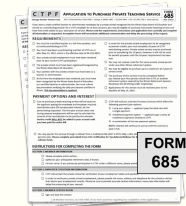
- View and update address information (if you are not currently contributing to CTPF).

## Private Teaching Service Purchases

State certified teachers or administrators previously employed by a private school recognized by the Illinois State Board of Education who have 10 years of CTPF service, may be eligible to purchase private teaching service.
