2024 Return to Work Legislative Updates

On June 5, 2024, the Governor signed legislation extending the allowable number of days per school year on which a retiree can return to work on a temporary and non-annual or hourly basis without having a pension cancelled from 120 to 140 through June 30, 2027. June 1, 2024, AARP Medicare Supplement Plan F (UnitedHealthcare) Rate Increase



Members who participate in the AARP Medicare Supplement Plan F (UnitedHealthcare) recently received a letter from UnitedHealthcare (UHC) with information regarding a June 1, 2024, rate increase. Plan F premiums are based on age, gender, vary by geographic area, and are determined directly by UHC.

The subsidized increases range from \$4.01 to \$23.02 per month and vary by individual situation. A majority of participants will have rate increases of \$16.97 or less. The new rate quoted by UHC does not include a CTPF member's 60% health insurance premium subsidy or the cost of the Express Scripts Medicare Part D pharmacy benefit. [Learn more here.](#)

New Deadline This Year!

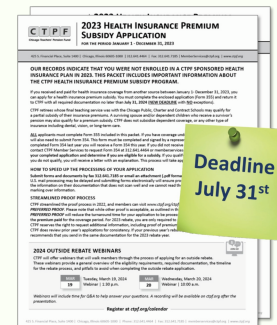
The deadline to submit applications is **July 31, 2024** (with **NO** exceptions).
